

**VIRGINIA PRESIDENTIAL PASO FINO HORSE ASSOCIATION, INC.**  
**AGREEMENT FOR STALLION BREEDING SERVICE AUCTION DONATION**

The undersigned, stallion owner/agent, hereinafter known as, Donor, donates, at no cost, to the Virginia Presidential Paso Fino Horse Association, INC., recognized PFHA Region, P.O. Box 12, Mt. Jackson, Va. 22842, Email: Info@VAPPFHA.com, Fax: 540-740-3207, 13289 Spring Rd., Rockville, Va. 23146, hereinafter known as VAPPFHA, one (1 OR MORE) stallion service(s) (breeding service(s)) to the stallion listed in this contract, by person/agent or entity owner of said stallion. This service is to be auctioned by VAPPFHA until sold, but not to exceed a two (2) two year period, such period to be commenced the date donated, using this contract, and ending date the last day of the 2 year continuing period. If for any reason the stallion should become injured or otherwise, and not able to breed successful and/or make a mare pregnant for any reason whatsoever, it is the responsibility of the Donor to notify the VAPPFHA and Purchaser of highest bid for the service, hereinafter referred as Purchaser, whose contact information listed below, immediately to fully protect the VAPPFHA and Purchaser's interests. Donor and Purchaser have read this entire contract and understanding that it is legal document agreement bound by the laws of the Commonwealth of Virginia.

This contract must be completed and executed by DONOR, properly presented to VAPPFHA, with the following attachments to the contract marked as Exhibit A, a signed VAPPFHA current stallion service Donor's Contract, a copy of the official PFHA Registration (or other) document that is currently in affect exhibiting statement of the current owner of the stallion Donated, and Donor's contact for serve Breeding Farm/Business Contract signed by Donor/Owner of Stallion whose service is donated. Purchaser shall sign and execute this contract.

2. The stallion service may be auctioned by VAPPFHA on its stallion breeding web site and/or silent open bidding at each show during the year \_\_\_\_\_ and year \_\_\_\_\_ show seasons. such as VAPPFHA sees beneficial to facilitate bidding and or market with Picture/Videos if avail.

3. *Should the stallion, whose service is donated be sold, before this breeding has been used, the Donor is to ensure that this agreement will be a legally bound part of the sales/transfer ownership contract and honored by the new owner/agent as agreed.*

4. The Donor is subject to all the conditions of VAPPFHA Stallion Service Auction Agreement, and the policies and rules governing the Stallion Service Auction rules pertinent to the contract under the **laws of the Commonwealth of Virginia.**

5. *The Donor is to provide a copy of the breeding contract to VAPPFHA (address, provided below), within five (5) business days of donating the breeding, along with a signed copy of this donation.* The sale of the stallion service (breeding) will be subject to this breeding contract, and when signed by the Donor and Bidder becomes a binding contract between the Donor and Bidder. DONOR GIVES THE VAPPFHA THE POWER OF ATTORNEY FOR SIGNING ANY AND ALL DOCUMENTS ON THEIR BEHALF FOR ALL NECESSARY FORMS FOR THE REGISTRATION OF THE RESULTING FOAL, OR FULL EXERCISE OF THIS BREEDING DONATION CONTRACT AGREEMENTS.

6. Donor may receive from the VAPPFHA Fifty (50%) percent of the highest bid purchase of each stallion service (breeding) should there be a sale of said compensated stallion service, within 45 days of the date of PAYMENT of sale of the stallion service by Purchaser to the VAPPFHA. VAPPFHA will keep the remaining 50% of the highest bid as monetary donation of Donor. VAPPFHA reserves the rights to advertise, exposes, and or promote the stallion service for any stallion participating in the stallion service auction as it sees fit to sell the stallion service donated.

7. If said breeding purchased through the VAPPFHA Stallion Service Auction, for valid reasons does not conclude in a successful breeding service sale, *the breeding service donated may be rolled over to the following year.*

8. *For the purpose of registration of resulting foal,* Donor will provide a breeding contract to the final highest Bidder, Purchaser, by breeding service being provided. *The contract will be binding between the Donor and the Purchaser to protect both parties from unnecessary expense* for either Donor or Purchaser signing this contract and including a signed PFHA/or other registry entity, Breeders Certificate and submitting a Stallion Report to the PFHA or other registry noted at the time of the actual breeding of the mare to the stallion.

9. Donor will be notified by VAPPFHA within Forty-Five (45) days of the sale of the breeding service with Purchaser's Contact information and payment if any to Donor.
